

## Terms and Conditions

In these terms 'We' or 'Us' or 'Our' means SKIABLINDS.LLC ("skiablinds"). 'Product' means the blinds, other products manufactured or supplied by Skiablinds and the subject of the order made by You.

'You' and 'Your' means the person ordering the Product from Skiablinds. 'Website' means the website located at [www.skiablinds.com](http://www.skiablinds.com) or any subsequent URL which may replace it.

## Price Match Guarantee

To make a Price Match claim, submit a competitor's quote for our review. The quote will need to detail the following:

Company details / Product(s) / Size of blind(s) / Type of blind(s) / Fabric / Delivery time

Quotes must be dated within the last month. The prices matched must be for blinds/products that are the same in style, specification, size, color, quality, delivery time and offered on the same terms. The price(s) matched must include VAT and delivery charges where applicable. We reserve the right to withdraw/amend this Price Match Guarantee at any time.

## Payment

All prices shown include VAT. We accept MasterCard, Visa credit and Visa debit cards. We also accept cheques made payable to SKIABLINDS.LLC (Orders paid by cheque will not be processed until funds are cleared.)

Once your order is placed and payment is received a legally binding contract with you will arise.

## The Contract and Your Right to Cancel

Made to measure blinds are classed as 'bespoke' and are exempt from the 14 day cancellation provision of the ICAC Regulations.

Therefore, you cannot change or cancel your order as the goods are custom made to your requirements and would not be re-saleable by us.

We will make all reasonable attempts to notice any irregularities in the orders for made to measure blinds, but ultimately we cannot be responsible for any errors made by you.

## Delivery

Delivery takes about 2-3 weeks as the product is produced in Korea and shipped to the head office. The head office receives the product and contacts the customer about the installation schedule.

We shall not be liable for loss occasioned by delay in delivery or arising out of any cause beyond our control.

## Unforeseen Circumstances

If, due to unforeseen circumstances, we are unable to supply all the goods you have ordered we will contact you within 48 hours of receiving your order. You have the right to cancel your order if we are unable to complete the whole order.

If we are unable to contact you we will assume that you would want the whole order to be cancelled and we will not make any part of your order or charge you any amount.
